## **BRIDGEPORT MEMORIAL PARK AND PLAYGROUND RULES**

- Park and playground close at dusk. This rule shall be waived if in a special designated lighted area.
- No parking of motor vehicles allowed on any grass area of a playground or park.
- Absolutely no dumping of debris, litter or waste on playground and park grounds. All trash must be placed in proper receptacles.
- No golf or driving of golf balls permitted.
- No bicycles, skateboards or scooters are allowed to be ridden on the premises.
- A permit must be secured from the Bridgeport Community Fund for use of fields and facilities.
- **Alcoholic beverages are prohibited. No person may sell, possess, or consume any alcoholic beverage.**
- Damage or vandalism should be reported to the Bridgeport Police Department (610.272.5660). Violators will be prosecuted.
- Dogs are permitted in Dog Walk ONLY and must be on a leash. All feces must be removed.
- Play at your own risk.
